



TURKISH QUALIFICATIONS FRAMEWORK (TQF) ACTION PLAN

"The Regulation on the Procedures and Principles Concerning the Implementation of the Turkish Qualifications Framework" was entered into force with the Cabinet Decree no 2015/8213 upon publication in the Official Gazette no 29537dated 19/11/2015.

As per the second point of the 1st provisional article of the Regulation, TQF Document prepared within the scope of the operations conducted in the period of 2010-2014 and approved by the Vocational Qualifications Authority Executive Board was published in the Official Gazette no 29581 and dated 2/1/2016.

TQF Council which is foreseen in the Regulation was established following the enforcement of the TQF. The first task of the TQF Council is to prepare the TQF Action Plan for a three year of period as per the TQF Regulation. Within this scope, the below presented plan was developed under the coordination of TQF Department and in cooperation with the Working Group composing of the members of the Ministry of National Education (MoNE), Council of Higher Education (CoHE) and Vocational Qualifications Authority.

The plan is basically a road map for the implementation of the TQF even if it is called as an Action Plan, and this plan includes information about the criteria, procedures, principles stated in the TQF Regulation and about when, by whom and how the plans will be prepared.

During the preparation of the plan, all the actions referred in the TQF Regulation and TQF Document were identified, prioritized and scheduled. Although many actions were deemed primary, it was decided to give priority to the actions that create a precondition for the launch of the other actions.

Rather than identifying ambitious start and end dates for the activities and falling behind the determined goals, an effort was devoted to be realistic as much as possible and to take the current human and financial resources and the time into account.

Certainly, some of the actions can be completed earlier than foreseen date and some of them may take longer time than expected. If any action is completed earlier than expected, the following actions will be started and sometimes actions will be carried out simultaneously.

It is considered that the process will gain impetus with the technical assistance to be provided by the European Union funded project which is aimed to be launched in 2017 and which is focusing on the implementation of the TQF.

During the development of the plan, current/future human resources of the TQF Department that is responsible for provision of the secretariat services relating to TQF and the support that can be provided by the EU Projects planned to be launched and the MoNE and CoHE as the institutions bearing the main responsibility.

The meanings of the terms used in the Plan are as follows:

Responsible Bodies: Ministry of National Education, Council of Higher Education, higher education institutions, Vocational Qualifications Authority and other relevant institutions and organisations stated as responsible for the qualifications in the TQF Regulation;

TQF Boards: TQF Coordination Council and TQF Council;

TQF Secretariat: TQF Department, the staff seconded by the MoNE and CoHE, working groups, the team of national and international experts;

TQF Regulation: The Regulation On The Procedures and Principles Concerning The Implementation Of The Turkish Qualifications Framework.

For the upcoming three years, all the works related to TQF will be carried out in the light of TQF Action Plan to be finalized in line with the opinions and suggestions of the TQF Council.
